The following items are required the day of your audition:

- 1. One 8x10 photo in a dance pose.**
- 2. A 50 second dance solo prepared with music on ipod, phone, IPAD or cd**

Dancers are required to wear the following:

Girls / Women: Must wear black leotard and pink tights. No ballet skirts, leg warmers or shirts permitted. Hair neatly secured in a ballet bun. Ballet shoes are required and jazz shoes are suggested.

Boys / Men: Must wear black sweatpants and a tight fitting white t shirt. Jazz shoes and ballet shoes are suggested.

Day of auditions:

It is recommended that you arrive 15-20 minutes prior to your audition time in order to turn in your photo and music and warm up. Auditions will begin promptly at the specified times. The audition will begin with a class and/or combination in three dance genres. Dancers will then be presented with a combination choreographed for the specified company level. Dancers will be broken into small groups to perform the combination in front of the judging panel.

The Directrice will notify dancers via email of audition outcomes.

****Interested dancers are encouraged to visit and observe a rehearsal session of the company for which they are applying to audition, as well as contacting the Company Director for recommendations regarding requirements and placement.****
